# Legislative Updates

## SHB 1947 Technology governance

- WaTech's agency request legislation has three policy goals:
  - Clarify names by aligning statute with WaTech's "doing business as" name.
  - Clarify authority by affirming the agency created by the Legislature is the single information technology agency in the state.
  - Clarify responsibilities by bringing statute in line with current operational processes or with a more appropriate book of business.
    - Sec. 20 and Sec. 62 move statutory authority for the SIEC from WaTech to the Military Department.

# Cybersecurity Grant Updates



## **FY22 Funding (\$3.7M) and Project Status:**

### **71 grant recipient agreements finalized**

- 51 agreements finalized and executed
- 20 outstanding for signature

Grant Recipients are reporting that they will be ready to start reimbursing for costs in 3-6 months.



## FY23 Funding (\$5M) and Application Status:

- NCSR webinars on Dec 6, Jan 9; Jan 26 FY22 grant recipient webinar.
- 19 projects selected for revision and resubmission are in the process of being prepped for scoring and ranking.
- Updated FAQ web page in process.
- FY23 New application round target Spring 2024.
